

## STATE COURTS SYSTEM

### Public Records Exemption Certification Form

The following public records exemptions apply to personal information contained in State Court System records. These exemptions do not protect personal information contained in records held by other state or local governmental entities. Therefore, court employees and judicial officers must submit a written request to other governmental entities to protect their personal information.

All social security numbers held by the State Courts System are confidential under Section 119.071(5)(a)(5), Florida Statutes.

\_\_\_\_\_ active or former Department of Children and Families personnel whose duties include the investigation of abuse, neglect, exploitation, fraud, theft, or other criminal activities.

\_\_\_\_\_ active or former Department of Health personnel whose duties are to support the investigation of child abuse or neglect.

\_\_\_\_\_ active or former Department of Revenue or local government personnel whose responsibilities include revenue collection and enforcement, or child support enforcement.

\_\_\_\_\_ firefighter certified in compliance with Section 633.35.

\_\_\_\_\_ current or former human resource, labor relations, or employee relations director, assistant director, manager, or assistant manager of any local government agency or water management district whose duties include hiring and firing employees, labor contract negotiations, administration, or other personnel-related duties.

\_\_\_\_\_ current or former state attorney, assistant state attorney, statewide prosecutor, or assistant statewide prosecutor.

\_\_\_\_\_ current or former United States attorney or assistant United States attorney.

\_\_\_\_\_ current or former United States Court of Appeals judge, United States District Court judge or United States Magistrate judge.

\_\_\_\_\_ current or former code enforcement officer.

\_\_\_\_\_ current or former juvenile probation officer, juvenile probation supervisor, detention superintendent, assistant detention superintendent, senior juvenile detention officer, juvenile detention officer supervisor, juvenile detention officer, house parent I or II, house parent supervisor, group treatment leader, group treatment leader supervisor, rehabilitation therapist, and social services counselor of the Department of Juvenile Justice.
